School Fee Rules and Regulations PAYMENT SCHEDULE (School Fee)

It is obligation of parent to pay the school fees/ dues on time. Non-payment of school fee on time can attract penalties and even the name of the child can be struck of from the school. School cannot be blamed for your negligence in any case. Fee concessions/ discounts cannot be claimed as right in any case

MODE OF PAYMENT

- 1. **Through Website:** You may visit our school website <u>www.davtheog.in</u> and click on online fee payment. (User ID and Password will be provided by the school)
- 2. **By Cheque:** Cheques are to be drawn in favour of "DAV CENTENARY PUBLIC SCHOOL" with the Admission No, Name of Student, Class, and telephone at the back of the cheque. Payments by Cheque/ draft without a late fee will be accepted by the 7th of the Month. In case payment is made by cheque and the cheque is dishonoured, a penalty of Rs. 500/- (over and above the late fee fine) will became applicable.
- 3. At school counter: Parents can pay fee at school counter. Fee at the school counter can be made through UPI/Debit/ Credit cards only.
- 4. Cash payment is not accepted.

PAYMENT

- 1. No partial fee will be accepted in any case.
- Fee/Tuition Fee is liable to be paid for twelve (12) months. Students of Class Nur to 10th joining in February/ March shall pay Fee/Tuition Fee for twelve (12) months i.e., from April 2025 to March 2026 for the session.
- 3. If the fee is not received by the 10th of the month, a penalty of Rs. 10/- shall be levied per day from the 11th day of the month.
- 4. In case of non-payment of fee (including late fee) for three months, the name of the student will be struck off the rolls on the last working day of Quarter (Three month) without giving any notice. He / She will not be allowed to attend the classes and not be allowed to take unit/ term/ final examination.
- 5. The student will be readmitted only after the payment of arrears and readmission fee per school rules.
